There are two options for your tuition payment plan for next year.

OPTION #1: Requires Participation in Fundraising*

Tuition Assistance

- **Diocese of Joliet Catholic Education Foundation (Kindergarten-8th grade)**
Applications for this program are available in the school office and are typically due in the early spring prior to the start of the next school year.
- **Tuition Grant Program (Kindergarten-8th grade)**
This program provides grants to families throughout the year. Members and friends of the supporting parishes, St. Joseph and St. Charles Borromeo, provide funding for this program. Contact the school office for specific information and eligibility requirements.

Earned Tuition Reimbursement Programs

- **Retail Gift Cards* (Manna/SCRIP)**
This program provides you with full percentages given by the retailer from the purchase of gift cards that can be applied to the current school year. Sell these cards to friends, family and co-workers to help your credits grow.
- **Market Day***
Market Day offers 10% of each purchase, which can be applied as credit towards your current year's tuition. Specific months offer bonus credits on seasonal products. For example, during the month of November, the pie drive features extra rebate amounts that increase your total benefit. Sell these bonus products and see how fast credits add up.

* Credit from these programs can also be applied toward other funds, such as our Tuition Grant fund instead of your own tuition or can be dedicated to one of the supporting parishes. Exact dates when credits will be distributed will be announced.
